

Terms and Conditions

New Zealand Kitchen Quarantine prize draw ("Prize Draw")

These are the terms and conditions (the "Terms") that govern the relationship between you, the entrant ("you", "your(s)") and New Zealand Trade and Enterprise, New Zealand House, 80 Haymarket, London, SW1Y 4TE, United Kingdom ("**Promoter**", "**we**", "**our**", "**us**") in respect of the Prize Draw.

ELIGIBILITY

1. Entry to the Prize Draw is open only to individuals aged 18 years or over.
2. Participation in the Prize Draw is limited to one (1) entry per person.
3. The following are not eligible to participate in the Prize Draw: (i) employees of the Promoter, its legal, financial and other advisors, its agents, media agencies, and other suppliers; (ii) immediate families of such employees or of anyone with whom such employees are domiciled. In these Terms, "immediate family" includes mother, father, brothers, sisters, sons, daughters, in laws, spouse or partner; and (iii) the Independent Observer (defined in rule 12 below).
4. By entering the Prize Draw, you confirm that you have legal capacity to enter the Prize Draw and you agree to be bound by these Terms (i.e. that you are of sufficient age and mental capacity and are entitled to be legally bound in contract) and by our decisions, which are final in all matters relating to these Terms, the Prize Draw and the winners' selection.
5. The Promoter reserves the right to verify the validity of entries, and request winners to provide proof of identity, residence and age. The Promoter will not retain copies of any such proof.

PROMOTION PERIOD

6. The Prize Draw commences on **Friday 15 May 2020 at 7.30pm BST** and closes on **Friday 29 May 2020 at 7.30pm BST** (the "Entry Period").

HOW TO ENTER

7. To enter this Prize Draw, you will need to: (a) complete a the entry form found at the following link <https://www.newzealandbusiness.nz/kq> , providing your full name, postal address, email address, and phone number ("**Entry Form**"); and (b) submit your completed Entry Form as directed by the Website during the Entry Period.
8. Any Entries which do not meet these Terms will not be valid and will be automatically disqualified
9. All Entries become our property and will not be returned.
10. Entries received outside the Entry Period will be ineligible for entry.

WINNER SELECTION

11. The winner's selection will take place at New Zealand High Commission in London, 80 Haymarket, SW1Y 4TE, London, UK in the presence of an independent observer ("**Independent Observer**") on **Friday June 5 2020**. One winner will be selected.
12. The winner will be contacted via telephone and email by the Promoter following the winner's selection on **Friday 5 June 2020 ("Notification")**. The winner must confirm their acceptance of the prize by responding to the Notification by return email by no later than **5pm BST on 19 June 2020**.
13. If the winner: (a) does not acknowledge their prize by **5pm BST on 19 June 2020** ; (b) cannot be contacted after two (2) attempts within three (3) business days of the winner's selection; (c) has contravened any of these Terms; or (d) is unable to accept the prize then the prize is forfeited and a further draw(s) will be conducted to select an alternative winner.
14. The Promoter's decision is final and no correspondence will be entered into.

PRIZES

15. There is one (1) prize comprising a premium hamper of New Zealand food and beverage products: .
16. The prize is non-transferable and there are no cash alternatives or other substitutes.
17. The Promoter will liaise with the winner to arrange delivery of the prize to the winner at the winner's nominated address within thirty (60) days of the winner's confirmation of the Notification.

18. All other expenses not expressly specified herein are the sole responsibility of the winner.
19. A prize may only be redeemed by the winner and the winner may be required to present personal identification documents to prove their identity.
20. If due to circumstances beyond our control we are unable to provide the stated prize(s), we reserve the right to award a substitute prize(s) of equal or greater value.
21. All prizes are subject to the terms and conditions of the manufacturer or supplier.

GENERAL

23. We accept no responsibility for any illegible or incomplete Entries or any incorrect or inaccurate information or lost or late Entries. Neither the Promoter nor any other person or party associated with this Prize Draw shall be liable for any loss or damage whatsoever suffered (including but not limited to indirect or consequential loss or damage) suffered or sustained in connection with either participation in this Prize Draw or with any prizes offered, except for any liability, which cannot be excluded by law (in which case such liability is limited to the maximum extent allowable by law). Nothing herein limits our liability for death or personal injury caused by our negligence.
24. This Prize Draw and these Terms are governed by English law and by entering this Prize Draw you acknowledge and agree to submit to the non-exclusive jurisdiction of the English courts.

PERSONAL INFORMATION

25. **The Promoter collects participants' personal information (including name, postal and email address and phone and mobile number) for its legitimate interests, including in order to conduct and administer the Prize Draw and to inform entrants, upon request, of the winners' details (in accordance with rule 23 above) and fulfilling prizes where applicable. If the information requested is not provided, an entrant may not take part in the Prize Draw. The declared winner's information may be seen by the Independent Observer, solely to witness the prize draws. If the information requested is not provided, you may not take part in the Prize Draw. If you are declared a winner, you authorise us to share your information with the company delivering the prize to your premises. The Promoter may use the winners' personal information (including the winners' names, biographical information, photographs or other likeness in all media and formats whether now or later known or developed, without any time or territorial limit and without further notice or compensation, and may require their appearance at publicity events without any additional compensation (save for reasonable travel expenses) as required by the Promoter to identify them as the winner of the Promotion (including on the Promoter's or any third party media company's websites, publications and social media platforms) without any further reference, payment or other compensation to the winner.

Unless participants have explicitly opted-in to receiving marketing communications from us, the Promoter will destroy other personal information collected from participants within two months after the Prize Draw is completed, save for information used for publicity purposes, which may remain available on the Promoter's or third party social media or other platforms.
